PART 1 – INTRODUCTORY PROVISIONS

Short title

1.1 This regulation may be cited as the Annual Rates Regulation, 2016.

Application

1.2 This regulation establishes the tax rates for the 2016 taxation year for taxes levied under the Act.

Definitions

1.3 In this regulation:

“Act” means the Real Property Tax Act.

- 2.1 The tax rates set out in Schedule 1 are prescribed under section 6.1 of the Act for the 2016 taxation year.
