# YG's Accomplishments

Have you ever wondered what the YG has accomplished? Quite a bit actually; here are just some of what we have accomplished:

- The Ucluelet First Nation is the second First Nation in Canada to adopt a Living Wage Policy.
- We have opened an urban office in Port Alberni, delivering on a promise of equality of all members and better contact with our urban members who compose approximately 70% of our Nation.
- Established and refined processes for responding to Freedom of Information requests;
- Enacted the Zoning and Structures Act, bringing greater certainty to land use decisions for Yuułu?ił?ath treaty lands;
- Enacted the Public Order, Peace and Safety (Animal Control) Amendment Act and related Regulation to provide the Yuulu?il?ath Administration with the tools to deal with dangerous dogs;
- Enacted the Subsurface Resources
   Act and related Regulation to provide
   guidelines for extraction of subsurface
   resources, particularly gravel, and

- ensuring the Yuulu?il?ath receives royalties for that extraction;
- Developed better and more direct working relationship with RCMP to increase their presence, and therefore safety, on Yuulu?il?ath treaty lands;
- Participated in the purchase of St. Jean's Cannery to create vertical integration of Yuulu?il?ath fisheries to maximize benefits from that Maa-nulth Treaty right and resource;
- Established and refined processes for transferring full ownership of homes and related Yuulu?il?ath treaty lands to Yuulu?il?ath citizens so they can access the capital value of their lands and improve their lives (11 transfers completed so far);
- Retained individuals with professional designations applicable to their job descriptions (Director of Operations; Chief Financial Officer; Lands Manager; Community Services Manager; Public Relations Officer);
- Arranged for education sessions for Yuułu?ił?atḥ citizens on property ownership and taxation under the Maanulth Treaty;

- Arranged for education sessions for Yuulu?il?ath citizens on Wills and Estates with an opportunity to have a professional Will prepared at reduced legal fees;
- Construction of additional social housing (duplexes and triplexes);
- Worked with the Canadian Coast Guard to allow the re-alignment of the Mt. Ozzard access road to a safer location with the decommissioning, rehabilitation and stabilization of the unsafe portion;
- We developed a great working relationship with Interfor for road access at Effingham which netted the nation 300k with an Impact Benefit Agreement – which has provided the funding for the Port Alberni office, additional funding for youth and elder programs;
- Finalized the reforestation and siviculture cleanup in the Nahmint Valley from previous logging;
- Secondary road access was negotiated with Probyn and clean up from previous logging practices. We faced a \$600k loss if not done in a timely fashion.

# Talking with our Legislative Representatives

Earlier this month, the YG Finance Committee reviewed the audit results of the consolidated financial statements for the year ended March 31, 2017. The findings report also included an audit of Implementation fund financial statements, CMHC Housing reporting, and a review of the Schedule of Remuneration. Accounting firm KPMG LLP presented their findings to committee members, who scrutinized the management report and discussed audit risks and results, adjustments and differences, and control observation. The Finance Committee subsequently passed a resolution to formally recommend acceptance of the audit report by the Legislature and the consolidated financial statements were presented at the last Assembly.

Understandably, accounting procedures don't excite too many people, so here are the main points you need to know:

- YG financial statements are a fair representation of YG's financial position;
- YG operations and cash flow are in accordance with Canadian public sector accounting standards;
- Collectively, our investments (Settlement trust, Implementation fund)

have increased by almost 2.5 million dollars this year;

- YFN Holdings Limited Partnership financial statements have been brought up to date;
- YG remains in good, overall financial health.

In coming months, the YG Finance Committee will be undergoing capacity building and improving financial literacy skills to further our role in providing strategic direction to the Legislature on decisions that have the potential to impact YG finances.

During the first week of September, a small delegation including myself, President Doiron and Director of Operations Rhonda Knockwood attended the BC First Nations Leadership and Cabinet Ministers Gathering to meet with BC Finance Minister Carole James. The conversation centred on tax revenue sharing and the need for YG to have increased taxation authorities in our new fiscal relationship agreement. As we approach critical dates with respect to existing status Indian tax benefits and YG's authority to collect taxes from citizens and non-citizens, this government is committed to ensuring the transition is as smooth as possible, and that our citizens are not negatively impacted as we draw down these taxation authorities in our Treaty. Currently, extensive preparations are underway to roll out a comprehensive communication strategy on taxation to citizens; stay tuned.

#### **Gordon Taylor**


I want to share with you some of the things I have communicated with my fellow Executive members:

- Legislators and Executive, it is important that we work as a team. I have been researching water sewage, hydro, maintenance and repairs since I was elected. I cannot proceed or start planning a five year housing plan without all of your input. We really need to work together as other nations have to help our people achieve their dreams, including bringing in more homes.
- We need Land and Resources to help identify future sub-divisions, lot sizes, road building, type of utilities (B.C. Hydro), alternative energy, gravel pits, forester to access trees, hydrologist, etc.
- We need the Finance department to help with infrastructure money, training funds etc.
- We need Social Services to help with job creation and training; for example, we do have members with survey experience & carpenters, training plumbers, electricians, equipment operators, solar panel installation training, etc.
- We need a full-time building maintenance person to operate and maintain our buildings.

- We really need to meet with the District of Ucluelet regarding a mutual aid agreement for fire coverage.
- We need help with training. What about having a community BBQ at our fire hall and sign up volunteers?
- We need to help Spencer and Jeremy with problems our Nation faces with our water pump system that was 95% complete when we got elected, yet two years later it is still not running as it should.
- We need to ask tough questions: Who or what is causing faulty service? Is it the installation work of our contractors or faulty equipment or location?
- Why don't we have a grant writer, to search for funding? I need support from each of you to get all of our government building using renewable energy.
   From my research it starts with us the elected officials and we must also form a committee to gather input from our community on renewable energy.
- We have 30 ICF (insulated concrete foundation) homes; all of them need complete hardy plank replacement as the underside is not treated. The previous Lands and Resource Manager agreed settlement over hardy planks is not even enough to repair even one unit.
- The last seven units built, the plumbing does not meet code. The floors are poor quality.

Please understand this is not about me or you, we are an elected body that must work as one in order to move to a better future.

# Managers' Reports

### Department of Social Services

Suzanne Williams

Youth Programming: As previously communicated to the parents of youth who might have attended the Summer Youth Program, the 2017 Summer Youth Program did not carry on as planned earlier in the year. This is in part due to staffing changes and changes in demographics of those children and youth that were eligible to attend the program. The Social Services Department analyzed data from previous years and recognized that an overall assessment of the program needed to take place in order to determine how we could better meet the needs of our young citizens. We are now taking a strategic and analytical approach with how we deliver programs and have started by offering age-appropriate programming as opposed to programming that was open to all age categories. We would like to thank those parents that came out to our first parent engagement session earlier in the spring and look forward to inviting more parents out to hear what you would like us to focus on in terms of program development and the needs of your children.

New Daycare: The Assets and Social Services Departments are working on a funding proposal to the Ministry of Children and Family Development for the creation of a new licensed daycare facility. The Yuulu?il?ath Government – Ucluelet First Nation has been selected to participate in Stage Two of the 2017/18 Major Capital Funding Intake Four. Our goal is that the new facility will serve as a cultural centre, a youth centre, and a daycare centre. Social **Development/Mental** Health and Addictions: Currently there are 30 clients receiving social assistance from the Yuulu?il?ath Government - Ucluelet First Nation (14 of which are employable). Per the 2016 Strategic Plan, the Social Services Department would focus on the completion of the SEEDS (Social Education Employment Development Support) Policy; however, more focus must be given to support our citizens with mental health and addiction services. At present, we will continue to encourage citizens to contact the NTC Mental Health Team staff as well as Addictions Counsellor, Deb Botting. In addition, arrangements will be made to have the Tsow-Tun-Le-Lum Society come to Hitacu regularly for traditional cleansing and healing.

Emergency Preparedness: On Friday September 8th the Yuulu?il?ath Emergency Operations Team hosted a Communitywide Drill to provide an opportunity for community citizens to practice getting to the safe zone in Hitacu. Approximately 30 community citizens participated and the ER Operations Team took away some useful tips to help improve the flow of handling an emergency situation (i.e. equipment needed, how and when to set up an official Emergency Operations Centre, and how much help we would need in the event of a disaster). We still have a lot of work to do and we will be participating in the 2017 Province-wide ShakeOut. Please stay tuned for more information.

### Department of Lands & Resources

September has been a time of transition for the Lands and Natural Resources department. The Coordinator for the Department, Levana Maestrangelo, has returned to school. YG thanks her for all of her support during the time YG was without a Manager of Lands and Resources. We all wish Levana well in her upcoming year of studies. The department has now filled the position of Manager of Lands and Resources for the interim.

This month the Nahmint V was put back in the water and returned to Hitacu after maintenance was performed in Port Alberni. Central West Coast Forest has been using the Nahmint V for phase II of the Effingham in-stream riparian restoration project. That project is now complete for the season and the Nahmint V will be utilized again by our department.

This summer has been plentiful with the annual food fish distribution for our Nation. We have successfully distributed Halibut and Sockeye to all of our citizens, local and urban. This would not have been possible without the tireless effort by all in the department and the much appreciated help from Law Clerk Christina Klotz. Two more fish deliveries to the Nation are in process and another distribution is expected for citizens in late September or early October.

There was a meeting planned in September for the regional working group on Human-Wildlife Coexistence but due to the transitions in the department it has been postponed until the 6th of October. Citizens are welcome and encouraged to attend. See the YG Facebook page for more information.

### Department of Asset Management

Finishing off this summer the assets department has had a few projects ongoing, we recently held a BBQ after the community emergency response drill, to drum up volunteers to the volunteer fire department, and as many of you are aware we are beginning the process of doing inspections on all the Nation's rental units to create 5 year housing plans, update our assets registry, and maintenance plans to go along with them.

We have been also working with a team from multiple departments to get the second stage of funding to build a new daycare in the community, which will also include a cultural component, and other functions.

The nation has also come into the possession of wood from the clearing of land from the new parks Pacific Traverse Trail, approximately five hundred cubic meters of wood from almost all the coastal species mix. We have begun stockpiling the Red Alder by the Cixwatin Centre for community use for smoking fish, and other uses. These Red Alder logs are available for any of our citizens to access.

Work is also moving ahead as planned with the seven new housing units. I would like to call out again to our community members with any construction experience looking for employment to subit a resume or even just some contact information on a note of what kind of construction experience you have.

I would also like to start working with the community on better managing our community wharf, throughout this summer we have had people utilizing the wharf from outside the community, putting our own members out of a spot to park their boat. Lands and Resources and Assets Departments will both be working together on a better way to identify our member's boats.

Čakup, Noah, and I spend part of our time in Macoah and the rest in Parksville where the girls go to school.

My passion for the last seven years has been forestry with the focus being on First Nations tenures. I have worked with nations all along the coast and have been privileged to work with my Nation on our forestry tenures for the last two years. My previous experience has taken me on adventures globally to work for organizations such as the United States Air Force, Manitoba Hydro and the Hudson's Bay Company.



I am very excited to hold the interim position of Manager of Lands and Resources. Being from a fellow Maa-nulth nation, I bring a solid understanding of what it means for the land base, as well as the citizens, to be under Treaty. I hope to aid the Yuulu?il?ath however I can in the management of your lands and resources.

# Qwayaciik?iis Day Care


Qwayaciik?iis Day Care has an unfinished playground next to the government office. Over time we have bought objects such as sandboxes, a playhouse and kitchen centre, slide and teeter-totter. We also have dug chunks of rounded wood ends into the ground for children to hop and balance on. In addition, we are in the process of moving the Little Tikes Playground set from our old day care location to our outdoor play space. This is going to be amazing for our kids.

During day care hours the playground is closed to the community, after hours it can be used. With this being said, there needs to supervision of children in the fenced play space and all garbage needs to be taken with the families. Lately when we open on Monday morning, there is garbage everywhere and items such as a children's chair and sandbox toys have been broken. In addition, the sandbox lids are off, which need to be closed for the purpose of preventing animal feces from getting into it. The playhouse roof was sunken in and almost broken. And sand is being taken out of the sandboxes.

The day care playground is for everyone and is currently the only outdoor play space that we have in HItacu. It is absolutely essential that we respect this area and treat it with the care it deserves so that all of our kids can enjoy the play area and receive the joy it offers. We do not want to lock this area up and close it due to vandalism and litter.

# Chief Clarence Louie Visit



On Saturday September 2nd, Yuułu?ił?atḥ hosted Chief Clarence Louie from the Osoyoos Indian Band. Chief Louie is a prominent First Nations leader and businessman and has been the Chief of his band for over 30 years. He has been credited with contributing to the economic success of his community and has received regional, national and international recognition, including the Order of British Columbia and Order of Canada.

Chief Louie spoke to our Nation and said, "We can't depend on the Department of Indian Affairs. That is a fatal experiment. DIA has never properly funded one program or service and never will." Chief Louie went on and explained, "That is why we need to start creating our own jobs, and making our own money to build stuff like Cixwatin Centre."

Chief Louie reminded us of an important historical fact: "The first entrepreneurs of this land were the tribal people. The first business people in Canada were the tribal people. We had trade routes; the tribes had trade routes between each other before European came." He went on to explain the importance of economic development and business, "before the Indian Act and

Indian reserves no tribe sat on their butts and asked for handouts, no tribal nation before Europeans came here sat on their butts and asked for a handout and expected someone else to feed them, clothe them, or shelter them. None of our Nations expected somebody else to do that for them. That was a responsibility handed down to us from our ancestors; namely, that we take care of ourselves. And today we do that with economic development. Today we do that through business."

Chief Louie talked about how is own mother sometimes disagrees with him and votes against where he wants to take his people. "Sometimes we disagree with one another. But you got to have that respect of being able to agree to disagree and like we say in hockey, leave it on the ice." Chief Louie went further with his hockey analogy to explain how at the end of a tense and emotional hockey game players after the game always shake hands and leave it on the ice. "All your resentment you leave it on the ice."

When talking about leadership, Chief Louie said, "being a leader is just not on the Chief and Council; rather, anybody who collects a paycheque on behalf of the government







is a leader. Each person holds a position of leadership to advance their First Nation."

Chief Louie also spoke of a "Res Culture." He said, "Res Culture is not our own culture. Before the 1870's we never had Indian Reserves, the Indian Act, elections. We all grew up under this Res Culture, which includes in-fighting, bitterness, even hatred. But this Res Culture is not our traditional culture."

Chief Louie concluded his speech by saying we First Nations people need to move away from Res Culture and get back to inter-tribal trade, and inter-tribal business. And get back to our traditional culture. He said he wants to see our ancient trade routes that Indian Affairs took away from us to come back. Key to this message is that we must take care of ourselves. "And today we do that with economic development. Today we do that through business."

On September 8,2017, the Hitacu Emergency Preparedness Committee (the 'Committee') held a community earthquake drill. The Committee has been working diligently over the last several months in preparation for the community drill and were very pleased to see citizens and members of the Legislature participate.

The two earthquakes in Mexico over the last couple of weeks highlight the importance of planning and preparation for emergencies.





### Where the Committee has been

The Committee began meeting in 2016 and established four goals:

- 1. to develop a draft Emergency Plan;
- to have consistent members and meet regularly;
- 3. to hold a community drill; and
- 4. to participate in Shake Out 2017.

Since the initial meetings in 2016, the Committee has achieved the first three goals

and are on track to accomplish all four as the plans to participate in Shake Out on October 19th are on track.

### Where the Committee is going


The Committee plans to keep refining the Emergency Plan, to keep meeting regularly, to continue holding community drills and to update citizens regularly of their progress and activities.

In addition to maintaining the goals above, the Committee has two main goals set for 2017/18. The 2017/18 goals are:

- 5. to ensure that as many Committee members and citizens are trained in emergency preparedness and first aid as possible; and
- to ensure that citizens and the Government have the materials and supplies needed to survive in an emergency.

### Parks Canada



Parks Canada would like to update you on some of the infrastructure work planned for Pacific Rim National Park Reserve this fall and winter. As always, we will do our best to keep you updated on any changes, or short-term visitor impacts over the next few months, but the information below should give you a broader picture of what construction work is happening in the national park reserve.

#### Rainforest Trail - Route B

Last winter Parks Canada staff replaced almost 1000m of decaying cedar boards with some beautiful and creative new boardwalks on Route A of the Rainforest Trail. The same work – replacing deteriorated structures - is planned for Route B starting on Monday, October 2nd, with completion expected in Spring, 2018.

During this time, Route B will be closed, but Route A and the Rainforest Trail parking lot will remain open to visitors. Our visitors have been wowed by the new boardwalk on Route A so we are very excited to see what the work crew can build this time around!

#### Washrooms - Incinerator Rock, Long Beach north, and Wickaninnish Beach

Three of the national park reserve's aging washroom buildings will be replaced this winter and will ensure ongoing services are available to visitors for many years to come.

This work is scheduled to begin on October 10th, and be completed by the end of Spring, 2018.

During demolition and construction of the new facilities, the following parking lots will be completely closed:

- Incinerator Rock parking lot
- Long Beach parking lot north end
- · Parking lot B at Wickaninnish Beach

Portable toilets will be available in nearby parking lots while construction is underway.

#### OTHER WORK ALREADY IN PROGRESS

#### The multi-use trail

Work to clear trees and shrubs along the trail route, from Incinerator Rock to the southern boundary of the national park reserve, is ongoing and should be completed by December. The next phase of the work will begin in the Spring of 2018. Following Parks Canada's established processes and rigorous standards for ecological protection, work will include preparation of the trail bed in both the southern and northern portions of the trail, including gravel, installation of drainage culverts, and fabrication of bridges.

#### The S-curve on Wick Road

Work to improve the safety of the S-curve and stabilize the slope is progressing well. The new roadway is being prepared for eventual paving and traffic delays are usually about 5-10 minutes. This project should be completed by the end of November, 2017.

#### The Kwisitis Visitor Centre roof

Contractors continue to work on replacing the roof on the visitor centre. While there is some noise, the visitor centre is open, and we are looking forward to having this project completed.

All of these projects represent a significant investment in the future of Pacific Rim National Park Reserve. We realise there will be some short term inconveniences to visitors, but look forward to the end results. Thank you for your patience during this work, and we will continue to provide updates by email and social media as the work proceeds.

# BC PHARMACARE PROGRAM WELCOMES FIRST NATIONS

# Some drug coverage changes are coming for First Nations in B.C.

Some drug coverage changes are coming for First Nations in B.C. BC PharmaCare program welcomes First Nations

First Nations in British Columbia are about to become the first in Canada to join a provincially-based prescription drug program.

Starting October 1 of this year, First Nations Health Authority clients with active Medical Services Plan (MSP) coverage will be eligible for the BC PharmaCare program.

If you have your MSP enrolled through FNHA, the move is automatic. A very small number of clients do not have MSP paid for by FNHA and will continue to have interim coverage with NIHB, ensuring you will get the drugs you need. To enrol in MSP, just contact your FNHA representative as usual.

The transition to PharmaCare is part of an overall plan to bring decision-making about health benefits closer to home and into the hands of First Nations. Bringing the program home to B.C. is our first step in improving it.

We ask that FNHA clients continue to take both their BC Services Card (or CareCard) and Status Card to the pharmacy when filling prescriptions.

Our current clients will continue to be eligible under PharmaCare for the medications they need - but a small number of recipients may have to change to a different comparable drug. If this happens to you and you have any concerns, please discuss it with your doctor or pharmacist.

We suggest that anyone prepar ing to travel out of province should plan ahead and fill prescriptions here in British Columbia before leaving. PharmaCare is a BC program, and cannot pay for prescriptions filled in other provinces. In most cases, clients are eligible to receive an advance supply lasting up to 100 days. Anyone needing more information before travelling should speak directly with a pharmacist.
